DHA is listed in the Food, Drug and Cosmetic Act (FD&C Act) as a color additive for use in imparting color to the human body. DHA has been approved by the FDA. However, its use in cosmetics - including sunless "tanning" products - is restricted to external application. According to the CFR, "externally applied" cosmetics are those "applied only to external parts of the body and not to the lips or anybody surface covered by mucous membrane" (21 CFR 70.3v). DHA reacts with the skin's amino acids resulting in a "tan" similar looking to that of the sun.

The FDA advises that spray tan users should avoid inhaling or ingesting DHA or letting the spray get into your eyes. When using DHA-containing products as an all-over spray or mist, it may be difficult to avoid exposure in a manner for which DHA is not approved, including the area of the eyes, lips, or mucous membrane, or internally. Therefore, it is recommended that you take protective measures to eliminate eye contact, inhalation or ingestion during your spray tan session, such as: Using protective eyewear, wearing nose filters, sealing lips with lip balm, and using protective undergarments.

If you have sensitive skin or allergies to sunless tanning products containing DHA, or if you are unsure whether you may be allergic to

DHA, we strongly suggest consulting your physician prior to tanning. We have copies of our solution ingredients for your physician upon request. If you have had adverse effects utilizing self-tanning products or moisturizers in the past, you may experience similar effects with sunless spray tan systems.

If you are pregnant, nursing, or plan to become pregnant we recommend each customer consult with their personal physician before receiving a DHA sunless spray tan application.

WARNING This product does not contain a sunscreen and does not protect against sunburn. Repeated exposure of unprotected skin may increase the risk of skin aging, skin cancer and other harmful effects to the skin even if you do not burn.

I have read the contents of this consent form carefully and state that I am not aware of any medical condition, allergies, or other reason that would prohibit me from sunless tanning. I have been given adequate instructions for the proper use of the sunless application, understand the risks involved, and use it at my own risk. I hereby agree to release the owners, operators and manufacturers from any damages that I might incur due to the use of this facility. I have been advised to discontinue use if any reaction occurs.
